## **KEYNOTE**



Hostile Nation: Compulsive Deportation and Inhumane Treatment of Underage Immigrants and Refugees Redefines American Values and Identity by Sheena Wadhawan, CASA de Maryland

**Sheena Wadhawan** is the Legal Program Manager at CASA de Maryland (CASA), the largest immigrants' rights organization in Maryland. She joined CASA in 2011 as a staff attorney specializing in employment law and workers' rights, and has been leading the program since 2013. CASA has over 50,000 low-income immigrant members at the forefront of the

immigrants' rights movement. When there is a crisis or benefit that impacts the immigrant community, CASA is a first responder. The recent surge of unaccompanied children fleeing severe violence and danger in Guatemala, Honduras and El Salvador has brought to CASA's doors an increasing number of traumatized and fearful children in need. CASA attorneys are counseling children facing imminent deportation, which in many cases means certain violence, sexual exploitation and even death. CASA's legal staff, trained in trauma-informed client counseling, works to ensure these children receive the services they need. In addition, CASA has worked to shift the public and policy discussion about this issue towards the children and humane solutions rather than partisan posturing, while it continues to push for administrative action to stop the deportations that are tearing apart immigrant communities.

From the outset of her career, Wadhawan has remained dedicated to a client-centered, community-based practice of law — a model combining law and organizing to create lasting, community-based change. Prior to joining CASA, Wadhawan had a private social justice law practice where she specialized in tenants' rights and represented low-income clients in housing-related matters including homeowners facing foreclosure and defending post-foreclosure evictions. Wadhawan started her legal career in the Oakland City Attorney's Neighborhood Law Corps where she used legal and non-legal remedies to organize and support Oakland's lowest-income communities in improving the quality of life in their neighborhoods, including litigating against wrongful evictions, and for the preservation of affordable housing for low-income seniors. Wadhawan served as Vice President of the South Asian Bar Association of Northern California in 2010. Wadhawan currently serves as the Vice Chair of the United States Commission on Civil Rights District of Columbia State Advisory Committee. The Minority Bar Coalition awarded Wadhawan with their Unity Award in 2010. An immigrant herself, Wadhawan speaks Hindi, Punjabi and Spanish.
