**Position:** Outstanding teacher of trumpet with strong performance skills in solo, orchestral, and chamber music settings. Collaborative working style.

**Qualifications:**

- Master's degree in trumpet performance required or professional equivalent.
- Evidence of successful teaching (preferably at the collegiate level).
- Evidence of successful professional performance in a variety of settings.
- Diversity, equity, and inclusion are high priorities for Towson University; applicants must articulate and demonstrate how they address these institutional priorities in all aspects of their teaching and as a faculty colleague.
- Currently active as a solo or ensemble performer.
- Strong leadership skills and demonstrated experience working collaboratively in a variety of settings.

**Responsibilities:**

- Teach undergraduate lessons in trumpet, direct and teach weekly master class (as determined by teaching load).
- Attend juries and student recitals.
- Participate, as available, in area and/or departmental activities such as Day of Brass and Percussion, etc.
- Potential to perform with faculty for occasional faculty chamber concerts.
- Additional duties as determined in consultation with the Department Chairperson.
