Course Overview

Crime scenes are much like archaeological sites in the sense that both are non-renewable resources. Investigators have one opportunity to collect data, be it artifacts or evidence, through techniques that are "destructive" to the scene as a whole. While crime scene analysis and archaeology may seem like different disciplines, they both seek to document areas of interest in their entirety before they are disturbed and preserve recovered items in perpetuity. For these reasons, the documentation, search, recovery, and packaging techniques used in forensic investigations and archaeology are identical.

Drawing from this archaeologically informed perspective, this course follows *Introduction to Forensic Crime Analysis* (ANTH 357) and will provide students with practical skills that are required to collect, process, evaluate, and package evidence recovered from the scene of a crime. Building on the same topics covered in ANTH 357, students will take a more in-depth look at issues surrounding the admissibility of scientific evidence in court, courtroom testimony, evidence presentation techniques, crime scene documentation, biological analyses of physical evidence, chemical analyses of physical evidence, blood spatter pattern interpretation, questioned document testing procedures, illegal drug analyses, trace evidence examination, and scientific report writing.

Learning Objectives

Among other things, by the end of the semester students will be able to:

- Articulate the application of archaeological documentation, search, recovery, and packaging techniques in forensic investigations.
- Assess the admissibility of scientific evidence according to standards established by Frye and the Federal Rules of Evidence.
- Interpret blood spatter and blood stain patterns.
- Properly recover impression evidence recovered from a variety of surfaces.
- Demonstrate an understanding of forensic serology as it relates to DNA analysis of human and non-human sources of evidence.
- Critically review notes, photographs, sketches, and reports that document a mock crime scene.
- Demonstrate an understanding of the process of forensic chemistry as it relates to the investigation of poisons and controlled dangerous substances.
- Identify sources of trace evidence and evaluate its "individuality."
- Classify fingerprints using the Henry system.
- Evaluate items of evidence and select appropriate latent print processing techniques.
- Properly document evidence using standard report forms and property sheets.

Mock Crime Scene

An at-home mock crime scene scenario will be given to each student toward the end of the semester. Students will be given instructions as to how to set-up the evidentiary items within the crime scene. Students will also be responsible for collecting, processing, and packaging evidence, and submitting a formal report, sketches and photographs.

Cumulative Lecture Examination

The exam will test your knowledge and understanding of the lecture topics and lab exercises covered throughout the semester. The format of the exam may include true-false, multiple choice, fill-in the blank, short-answer, and photo identification questions. This exam will be administered via Black Board. The exam will be timed and must be completed in one sitting.

Assignments

Assignments announced in class are due the following class. Due dates are also listed on the weekly schedule included in the syllabus but may be modified based upon material covered in class. Each assignment is worth 10 points and make up 25% of your final grade. Handwritten work will not be accepted. Reading quizzes are counted as part of the assignment grade.

Court Room Testimony Assessment

Students will be given a YouTube link in which they will review a Crime Scene Technician giving testimony. Students will also be required to read an article titled "Effective Courtroom Testimony" by Stevee Ashlock (article will be provided by instructor). Using what you learned from the article, view the YouTube video and give an assessment/ evaluation of the technician's testimony.

Attendance

Attendance is documented at the beginning of each class. Late arrivals will be denoted. Each class that you miss will result in a five-point deduction from your final grade. Exceptions will be given at the discretion of the instructor. You are responsible for obtaining all information that you missed while absent. I will not email copies of class notes, lecture material, or instructions for assignments and papers. You must get this information from a classmate. You must attend your scheduled section of the class.

<u>Missed Exams/Quizzes/Assignments due to Religious Holidays, University Sponsored Events or Sporting Occasions</u>

Religious absences are excused, but prior notification is appreciated. Absences due to sporting events are excused but require notification from your coach as well as submission of the standard sporting notification forms. I will not preread your submissions.
