
## **OFF-CAMPUS LIVING**

- 2. Is rent pro-rated when moving in and out?
- 3. When are payments considered late?
- 4. Are there additional fees on top of the rent?
- 5. Are there rules against personalizing your apartment?
- 6. Are pets allowed?
- 7. Is the deposit refundable? How do you get your deposit back?
- 8. Is there any maintenance work the resident is responsible for?
- 9. How often are the locks changed?
- 10. Who is in charge of pest control?

## **COMMUNITY POLICIES**

#### FRIENDLY REMINDER

Baltimore County: No more than two (2) unrelated persons can live together in a single family dwelling.

Baltimore City: No more than four (4) unrelated persons can live together in a single family dwelling.

Off campus behavior that is disorderly, disruptive or harmful to others in the community or the neighborhoods surrounding the University is subject to discipline by the University. Disorderly conduct includes, but is not limited, to underage alcohol possession or consumption, public intoxication, noise violations, public urination, and harassment of others.

#### 18-2-202. Obstruction of Streets and Allevs

#### (a) Prohibited. A person may not stop, park, or leave standing a vehicle on any road or alley:

(1) In front of or within 5 feet of the edge of any private driveway or parking area without the consent of the owner or occupant of the premises; or

(2) In a manner that prevents free passage of vehicles or the movement of a lawfully parked vehicle to or from a driveway or parking area.

(b) Parking in an alley. A person may not park, stop, or leave unattended a vehicle in any alley leaving less than 12 feet of clearance parallel to the vehicle.

Vehicles that do not adhere to these policies may be subject to be towed.

# PARTY AT YOUR PLA DID YQU 1. HAVING A LOUD AND UNRULY PARTY IS:

A gathering of four or more people at a residence or other private property where there is underage drinking or conduct disturbs the peace.

### 2. PERSONS RESPONSIBLE ARE:

The people who organize & supervise the gathering and any other person who accepts responsibility for the gathering.

### **3. PENALTIES FOR RENTERS INCLUDE:**

\$500 - \$1,000 in fines + community service per person responsible.

**4. PENALTIES FOR PROPERTY OWNERS:**


